

Application to inspect the NSW Electoral Roll for State Districts

Inspection will only be provided in accordance with section 39 of the *Parliamentary Electorates and Elections Act 1912* (PEEA) together with Part 6 of the *Privacy and Personal Information Protection Act 1998* (PPIPA) which requires the NSW Electoral Commission (NSWEC) to be satisfied that inspection of the roll is undertaken for a purpose relating to the purpose of the roll or the PEEA under which the roll is kept (a lawful purpose).

Use of a device (such as a photocopier, scanner, camera, telephone, mobile phone, voice recorder or video recorder) to copy, record or transmit the contents of the roll or any part of the roll is **prohibited**. Hand-written notes are permitted.

You are required to complete this form and provide photo ID upon request (e.g. drivers licence, passport). If the NSWEC is not satisfied that inspection of the roll is for a lawful purpose, your application to inspect the NSW electoral roll will be refused.
